A Message from Father Steven Mills



Dear Bishop Neumann Family,

I am new to this role of Chief Administrative Officer. I graduated from a Catholic school and I am all-in on Bishop Neumann and the education we provide for our students. Bishop Neumann's theme this year is **Be The Light**. I believe when we think of being the light, we tend to think of bringing goodness into other people's lives. But sometimes it is letting light shine in the darkness. Be The Light is rooted in not letting the dark moments of last year, or the dark moments in each of our lives win.

One way for us to grow in the light is to be transparent with our current financial situation. The numbers from last year were better than anticipated, but we still ended up in the red by almost \$190,000. We are able to cover this with our savings and with the help of our endowment fund, but those are limited for long term stability. This year the budget is going to be tight for a couple of reasons: rising costs, less savings, a decrease in enrollment, and a desire to minimize our parish assessments.

The result is a budget that was passed last year that is expected to run further in the red. We will try to make some adaptations and be sensible, but it is hard to make any drastic changes during the school year.

I know it is prudent to make our financial state known. HOWEVER, I have experienced the goodness of the Lord in a multitude of ways. I know that when we bring light into the darkness, God's power reigns. I know He is present in this school. I know He is working in our lives here at Bishop Neumann. I am filled with hope as I trust in our future. I encourage you to do three things:

- 1. Pray for our school
- 2. Be as generous as you can in whatever way you can
- 3. Listen to the words of Padre Pio: "Pray, Hope, and Don't Worry"

I have daily entrusted this school to God. He will do with it as He sees fit. These students amaze me day after day. We have incredible things occurring at this school that easily get overshadowed by darkness. It's time to Be The Light.


\$13,333 - Total Cost to Educate (2023-2024 Per-Student Costs)

The average cost to educate a student at Bishop Neumann High School was \$13,333 per student in 2023-2024.




